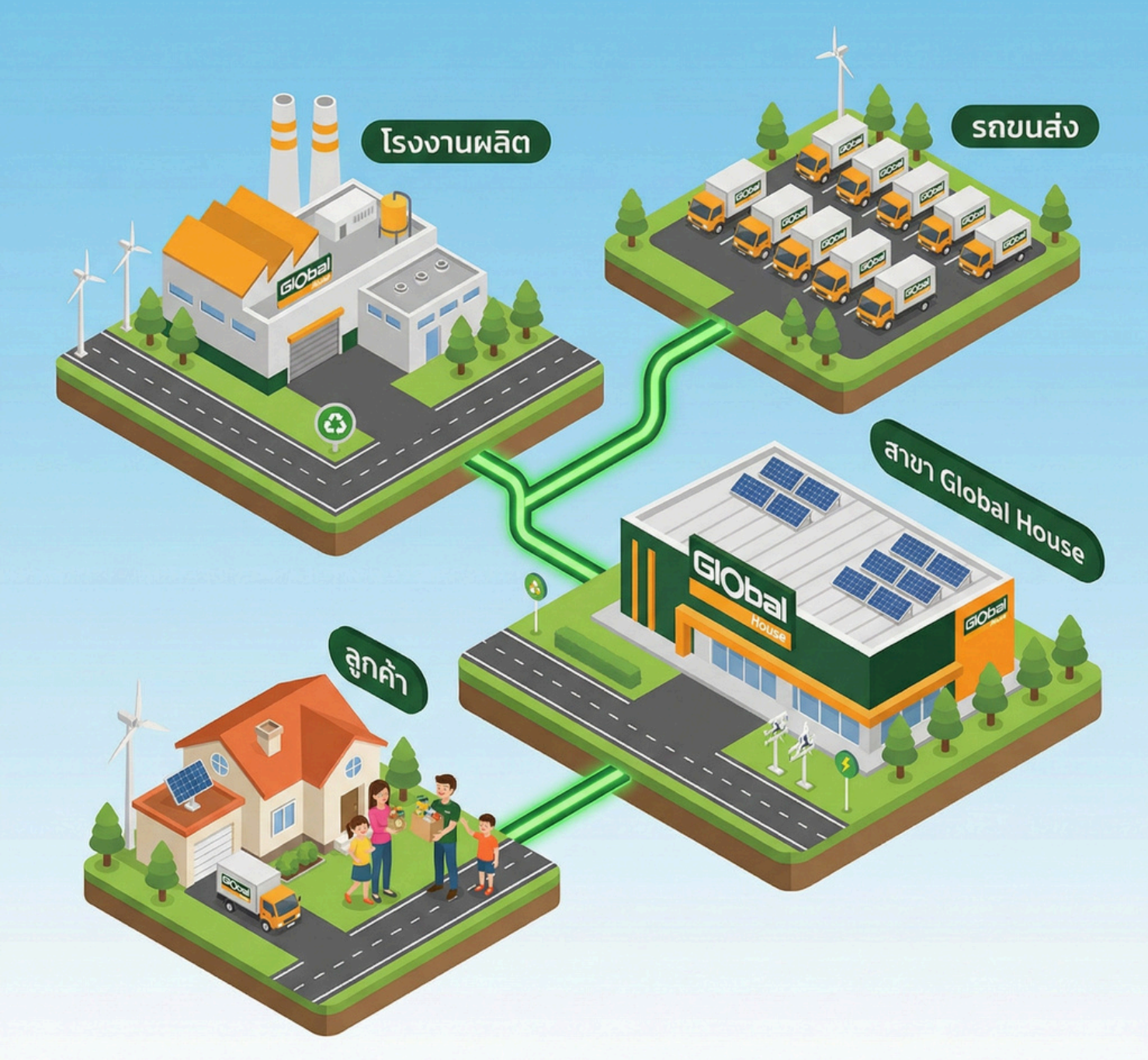

OBJECTIVES

The ESG Supplier Handbook serves as a guideline for the Merchandise Department of Siam Global House Public Company Limited to communicate expectations and oversee the ESG practices of suppliers and business partners across the supply chain, supporting sustainable, transparent, and social and environmental responsible business growth.



Scope of Application

- Applicable to all suppliers and business partners of the Company, including suppliers, vendors, Contractors, and Service providers.
- Covers the entire business relationship lifecycle, from supplier selection and onboarding, contract execution, performance monitoring, to supplier development.

SUPPLIER CODE OF CONDUCT

Suppliers and business partners are required to comply with the Supplier Code of Conduct of **Siam Global House Public Company Limited**

Which establishes minimum standards of Business Ethics, Labor Practices and Human Rights, Occupational Health and Safety, Environmental Responsibility and Climate Chang Adaptation.

The key principles are summarized as follows



Business Ethics and Corporate Governance



Conduct business with integrity, transparency, and accountability.

Strictly comply with all applicable laws, rules, and regulations.

Prohibit all forms of corruption, bribery, facilitation payments, and improper benefits.

Avoid and appropriately manage conflicts of interest.

Respect and protect information, business confidentiality, and personal data in accordance with applicable laws



Labor Practices and Human Rights



Prohibit child labor, forced labor, illegal labor, and human trafficking in any form.

Treat employees fairly, without discrimination, harassment, or abuse.

Respect human rights, freedom of association, and the right to collective bargaining in good faith.

Pay wages, provide benefits, and manage working hours in compliance with applicable labor laws.



Occupational Health and Safety

- Provide a safe, hygienic, and suitable working environment.
- Implement measures to prevent workplace accidents, injuries, and occupational diseases.
- Provide appropriate personal protective equipment (PPE) and necessary training.
- Establish emergency preparedness and incident response plans.

Environment and Climate Change



Comply with all applicable environmental laws and regulations.



Use natural resources, energy, and water efficiently.



Properly manage waste, wastewater, pollution, and hazardous chemicals.



Support and cooperate in initiatives to reduce environmental impacts and greenhouse gas emissions, as appropriate.

Whistleblowing Channel

Provide channels for employees and stakeholders to raise concerns or report misconduct.



Cooperate with the Company’s whistleblowing mechanisms and ensure protection for whistleblowers acting in good faith.

Suppliers must cooperate and provide information.

A whistleblowing channel is available.



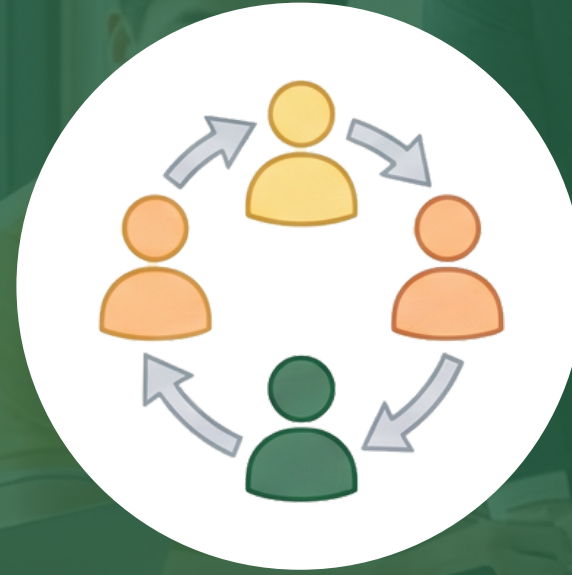


Measures for Non-Compliance

Provide warnings and a corrective period.

Temporarily suspend orders.

Terminate supplier status in serious cases.



Roles and Responsibilities of the Merchandise Department

Communicate this ESG Supplier Handbook to all suppliers.

Integrate ESG considerations into procurement processes and decision-making.

Monitor, track, and report supplier ESG performance.



Review and Improvement



Review and update this ESG Supplier Handbook at least once a year, or whenever there are changes to applicable laws, regulations, rules, or relevant standards.
